OUR DIVERSE OPERATION INCLUDES HERITAGE BREED LIVESTOCK, ORGANIC APPLE PRODUCTION, NO-TILL ORGANIC PRODUCTION FOR GRAIN CROPS AND VEGETABLES, ORGANIC WEED MANAGEMENT, MEASUREMENT OF SOIL CARBON ACCRUAL, PRODUCTION AND USE OF MYCORRHIZAL INOCULUM, AND INTEGRATION OF PASTURE INTO ORGANIC CROP ROTATIONS.
